## POLICIES

### REGISTRATION POLICIES

1. Payment of registration fees must be made in full at the time of registration or by down payment plus monthly post-dated cheques. Monthly payments are from October through January on the 20<sup>th</sup> of each month. Registration fees must be paid by January 20<sup>th</sup> along with any outstanding Fundraising balances of each year.
2. NBSC reserves the right to limit the number of skaters in each session and to modify or cancel any session due to low or excessive enrolment.
3. Skaters may only register for sessions for which they are qualified as per the Club defined skater levels.
4. Skaters may only skate on sessions for which they are registered. If they choose to skate on other sessions, they must pay a guest fee of \$20 per session.
5. If a skater misses a session, they will not be permitted to substitute skating on another session, unless they pay the guest skate fee. Should extenuating circumstances arise, such as significant time off for serious illness/injury, the executive must vote on concessions made to accommodate the skater.
6. A Skater must be registered with parental or guardian signatures prior to entering onto the ice.
7. There will be a \$45.00 cost for each returned cheque. Failure to pay within 10 days will result in ice privileges being revoked until the account has been settled and the member is once again in good standing.
8. If a refund is required, the amount paid will be prorated according to the number of days skated. The Skate Canada fee is non-refundable.
9. The Club does not pay any fees towards Low or High tests.
10. In order for a skater to register to skate with NBSC, their primary coach must have a coaching contract with NBSC.

## **MEMBERS IN GOOD STANDING**

All NBSC members must be members in good standing. This means all fees including registration, coaching, test day, competition or other fees are paid in full.

## **MEMBERS IN ARREARS**

As per Skate Canada rules, if club and private coach fees are not in good standing on December 31<sup>st</sup>, skaters will not be allowed to enter competitions or tests until such time as fees are paid in full. All registration fees must be paid in full by January 20<sup>th</sup>. Fees for tests and competitions must be paid to the Club when the registration forms are submitted, on or prior to the deadline specified.

## **GUEST SKATING**

Skaters may guest skate on any session at their qualification level, providing that there is adequate room on that session. Guest skate prices:

Members: \$20.00 per session

Non-members (must be registered with Skate Canada): \$25.00 per session.

## **GUEST SKATING AT OTHER CLUBS**

If a skater registers or guest skates at another Club, it is the responsibility of the parent to cover all costs including registration fees, test fees and extra ice fees. Members must remain in Good Standing with other Clubs as well.

## **REPORTING AN INJURY**

If your child is hurt at any time at an Arena, the City of Greater Sudbury requires the parent to complete an incident report at the time of accident. These reports can be found in the Arena Office. See the Supervisor on duty.

## **ICE CANCELLATIONS**

You will be notified by email of any unscheduled ice cancellations. NBSC will make every effort to make up ice time for unscheduled cancellations on alternate sessions.
