I am fully aware of the risks and hazards inherent in my attendance at the City Facility and participation in the Activities, and I voluntarily, knowingly and freely assume all risks associated with participating in the Activities at the City Facility, regardless of severity, including but not limited to my own actions or inactions (and/or the actions or inactions of my minor child/ward), the actions or inactions of others including but not limited to the City of Greater Sudbury and all of its elected and non-elected officials, officers, employees, agents, contractors, and subcontractors, servants, volunteers, successors and sponsors (collectively the "City" or "CITY"). I, for myself and on behalf of my heirs, assigns, personal representatives, next of kin, and those for whom I am responsible at law, **HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS THE CITY WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, INJURY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE OF THE CITY** to the fullest extent permitted by law.

I, for myself, my spouse (if any), and child/ward do consent and agree to the Attendee's release provided above for The City. **MYSELF AND MY SPOUSE (IF ANY), AND CHILD/WARD DO RELEASE AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE CITY FORM ALL LIABILITIES INCIDENT TO MY MINOR CHILD'S/WARD'S PRESENCE AND/OR PARTICIPATION IN THE ACTIVITIES.**
